Panel 1 Deciding How to Decide: Second Amendment Methodology, the Two-Part Test & the Supreme Court

Federal appellate courts almost universally apply a two-part test in Second Amendment cases, and most have applied intermediate scrutiny to regulations that do not severely burden the core of the right. Should the Supreme Court weigh in on the prevailing test and tiers of scrutiny, what factors are likely to influence the Court's assessment? What will the ramifications for Second Amendment litigants be going forward if the Court either accepts or replaces the two-step test?

Panel 2 Guns in Public: The Next Certiorari Grant & Beyond

The Supreme Court is likely to grant review in a case challenging restrictions on the carrying of guns in public. As with the Heller decision itself, the Court's next ruling on public carry is unlikely to resolve every important question relating to firearms in public. How should the issue of public carry and the Second Amendment be contextualized now, and how might it arise again in the future—including with respect to proposed "concealed carry reciprocity" policies, and Stand Your Ground laws that upend traditional standards for lawful self-defense?
